Many years ago as his university in Tulsa struggled to survive, evangelist Oral Roberts exasperatedly exclaimed: "It takes money to do things." Such is certainly the case for our governmental entities. Like most of you, my city has had its share of financial challenges over the years.

The OCEA treasury is a rock of stability thanks to many years of dedicated work by the board and individual members. Your support of this organization through annual dues, and conference and class attendance, allows us to be a financial beacon for other state code organizations.

That said, the actual reserves we currently have on hand are a bit lower than I'd like. Our conferences and classes cost money. As we have grown, our expenses have followed suit. This year's spring conference alone cost around \$28,000. We will take an anticipated loss on it to keep our fees reasonable and affordable for all communities in Oklahoma.

Our classes do well for themselves from a financial standpoint and are the backbone of our revenues. Yet recently, we planned for an April code class with 35 students and only 25 showed up.

I tell you this to say that the board will be looking at options in the coming months that are likely long overdue. OCEA has traditionally sought payment for conferences or classes after the event. We have ample reserves by design to pay for everything up front, but recovering those costs from our member communities can sometimes be a lengthy process. Most organizations require pre-payment of such fees, and that is an option under serious consideration.

I can assure you we will reshape a payment system than can work for all our member communities and their different forms of payment. It may take money to do things, but OCEA will always be at your service.

As the legislative session is winding down lots of bills of interest have been signed into law but one in particular stood out. SB 2361 was signed into law by Governor Stitt and this bill will come into effect in November. I had to have this one explained to me but overall, I believe this bill could be of benefit especially to smaller municipalities. The language indicates if a municipality has a lien interest in a property, you can demand in writing that the property be auctioned off in the name of the municipality. What this would ultimately accomplish is if the property did not sell, then the property would become owned by the municipality. For some of those smaller towns it would allow you to protect your interests without having to bid on the property.
